Colonel C. E. "Mel" Fisher Superintendent's Award

During each graduation class ceremony of the Missouri State Highway Patrol, a recruit is recognized as the Superintendent's Award recipient. This overall achievement award is presented by the superintendent to the recruit who has accumulated the highest number of points in the categories of physical fitness, firearms, and academics during the rigorous academy training programs. The award was recently renamed for future recruit classes as the Colonel C. E. "Mel" Fisher Superintendent's Award to preserve the legacy of a true agency leader whose commitment, vision, and service profoundly shaped the Missouri State Highway Patrol and the broader law enforcement community.

Colonel Fisher joined the Missouri State Highway Patrol on August 3, 1958, as a member of the 18th Recruit Class. He was appointed as the Patrol's superintendent on April 26, 1989. Under his leadership, the Patrol became only the tenth state patrol/police to achieve accreditation through the Commission on Accreditation for Law Enforcement Agencies (CALEA); the Crime Laboratory was expanded to include DNA testing; the Automated Fingerprint Identification System became operational; the drug interdiction and commercial vehicle enforcement program received national recognition; and the Patrol developed an emergency vehicle operations course for pursuit driving training. Additionally, Colonel Fisher instituted a physical standards program, peer counseling program, and created the Professional Standards Unit (now division). After 35 years of service, he retired on August 31, 1993.

On May 21, 2021, Colonel Fisher died at 86 years old. Colonel Fisher was best described as a "trooper's colonel," and his exceptional leadership style was recounted in a tribute essay written upon his death by a former member of his executive staff, Retired Captain Stephen R. Johnson, which has been edited for this article:

"To many, he was the most consequential superintendent of the Missouri State Highway Patrol, dating back to the early days of the organization when the likes of men named Ginn, Ellis, Casteel, and Waggoner were in command. Ultimately, we tend to measure success by the wake a person leaves, and Colonel Fisher left a great wake. His tenure was marked by incorruptibility and a keen understanding of the police function, from the streets to high command. He was, in fact, a gentleman who enforced the law.

After assuming command, Colonel Fisher immediately set to work with an eye to bringing the Patrol into the technological age while preserving the tradition that is the cornerstone of its success.

He assembled a personal staff and began a whirlwind of innovation, correctly anticipating the needs of a progressive state police agency and keeping the Patrol ahead of the curve. The Colonel regarded every human asset as critical to the success of the Patrol and respected every employee irrespective of their role. His style can be best described as that of Gen. Omar Bradley, another Missouri alumni. He was a master of his craft, but attributed his success to his field commanders, division directors and employees, never seeking personal recognition or credit.

The Colonel never lost his zeal for the job. He could be found flagging traffic and setting flares at an accident scene. When the Patrol was involved in a manhunt, he was on the frontline, not directing by phone miles away. He and his underboss formed a two-man entry team in a search for a police killer in small town America, making entries with guns drawn. He was the darling of the Jefferson City newspaper after personally and aggressively removing a heckler from a legislative gallery during a hearing. He never forgot that he was a police officer under the eagles of command. His car-to-car call at 1AM has sent more than one officer scrambling to straighten up his car before meeting the boss. He could be found in the field, at odd hours, contacting a road officer for coffee and conversation. No idle chat here, he would ask hard questions about needs and equipment at the service level.

On many occasions, he would call a road officer, meet him and climb in the officer's car for an hour or two, patrolling the zone. He worked incessantly to memorize the family data of officers in the field, often stunning them with his knowledge about their children and events. He also expected his field commanders to be active in the troop area. He was a strong advocate for training, in particular training centering around the use of force and current case law. He championed excellence. Colonel Fisher made the Patrol a better police organization, and by extension, the state of Missouri a better place to live."

Colonel Fisher ushered in transformative changes that continue to guide the agency today. We must always remain mindful of the foundation laid by those who came before us. Even as we are focused on the future and the issues affecting our organization, it is important to take the time to reflect on the past and recognize those, such as Colonel Fisher, who made an enduring impact. The Colonel C. E. "Mel" Fisher Superintendent's Award will be presented for the first time to a graduating member of the 123rd Recruit Class on Wednesday, June 18, 2025.

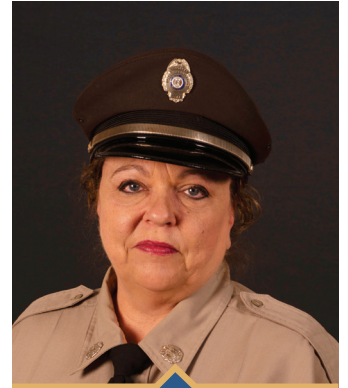

MSHP employees and their guests enjoyed a delicious dinner before the awards ceremony began. Major Corey J. Schoeneberg, (Q/ASB), performed as the Master of Ceremonies, and presented the keynote speaker, Missouri Secretary of State Denny Hoskins.

In his speech, Denny Hoskins said, "It's an honor to stand before this distinguished crowd, especially in this room, filled with so many who understand the true meaning of service, sacrifice, and strength. In every corner of Missouri, I've seen the same spirit — integrity, honor, and a fierce commitment to community. These are not just

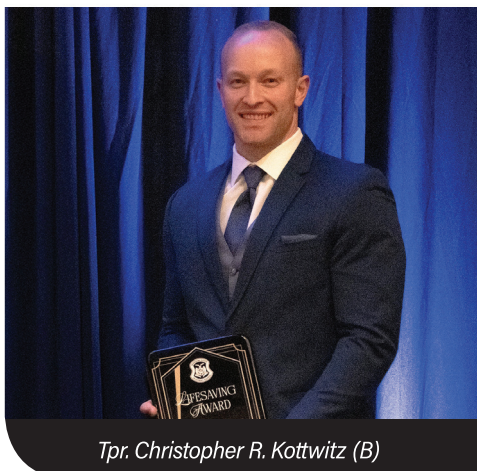

Officer of the Year

Sergeant Todd M. Barthelmass, (Q/GD), has been named the Gaming Division's Ace (Officer of the Year) for 2024. At the Missouri Gaming Commission meeting held on February 26, 2025, Gaming Division Director Captain Andrew O. Tourney, presented Sgt. Barthelmass with the award.

Sgt. Barthelmass is assigned to the Ameristar St. Charles and Hollywood Casino in St. Louis. In 2024, he uncovered a scheme to cheat at the card game Baccarat which cost the state of Missouri over \$400,000 in just nine days.

Sgt. Barthelmass investigated the scheme and discovered the same operation was being conducted in five other states, costing 2.1 million dollars nationwide. The suspects were arrested

within two months following the investigation.

Another example of Sgt. Barthelmass' dedication to duty came when a casino patron suffered a medical emergency on the gaming floor. The patron had no pulse and was not breathing. When Sgt. Barthelmass arrived, he began performing CPR on the man and saved his life.

Sgt. Barthelmass displays extraordinary initiative and leadership in his investigations and professional conduct. According to his colleagues, he is one of the most productive officers in both his zone and in the Gaming Division.

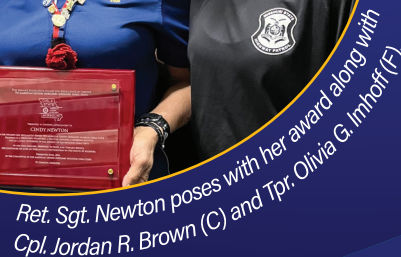

Tesch were celebrated for their work to stop an armed man who was pointing a loaded gun at casino patrons last year. As hundreds of casino patrons ran away, Sgt. Lairmore, Cpl. Pithan, and Cpl. Tesch ran toward the armed man and subdued him, resolving the crisis peacefully.

Colonel Michael A. Turner said, "The definition of valor is courage in the face of extreme danger and what you three did that day was extremely valorous. I'm proud of each of you."

He presented each of them with the Colonel's challenge coin.

DPS Director Mark James said, "I want to give you the Director's challenge coin as a token of my esteem and respect for the deed that you performed on behalf of the state. Thank you. What you guys did was a heroic action, no doubt. It's just a testament to the Highway Patrol, the core values that the Patrol instills, the training that the Academy puts in, that you just didn't hesitate. You saw a need; you saw people in danger. You reacted. You neutralized the threat, and here we are today, able to celebrate that!"

He also presented them with certificates commemorating their service.

Corporal Kyle A. Seabaugh (Q/DDCC) earned the DPS Sworn Team Member of the Month recognition for February 2025.

Cpl. Seabaugh has been working as the lead investigator on a child pornography case in Henry County since 2021. In March 2021, he organized a team of experienced investigators and conducted two coordinating searches. He found hidden evidence of child sexual abuse on a suspect's cell phone during his search. The suspect and a second individual were arrested and charged with sex trafficking, statutory sodomy, and rape.

Over three years, Cpl. Seabaugh and his team worked tirelessly to build their case, collaborating with a forensic pediatrician and an FBI expert to correctly identify the child victims. In June 2024, the initial defendant was found guilty on 23 counts of sex trafficking of a child, statutory sodomy, and rape. The defendant received 23 consecutive life sentences. The second defendant is still awaiting trial.

Captain Donald L. Crump (Q/DDCC) accepted the award on Cpl. Seabaugh's behalf. Kylie Dickneite, Director of Homeland Security, presented the award on behalf of DPS Director Mark James. Director Dickneite said, "On behalf of the director and the director's office, and all of the team at DPS, we want to congratulate Kyle. We're very honored that he serves in the Highway Patrol and does the work that he does every day."

DPS celebrated two members from Troop C, naming them the March 2025 Sworn Team Members of the Month.

Troopers Trey A. Gaedke and Justin D. Hedrick, Troop C, were awarded the recognition after they stopped a dangerous suspect fleeing Texas during a traffic stop last fall. The suspect had murdered a woman and set her house on fire in Texas. When Troopers Gaedke and Hedrick approached him, he began firing his weapon at them. They took cover and returned fire, ending the threat. Their courage and resolve undoubtedly saved lives.

Major Justin L. McCullough (Q/FOB), with the Field Operations Bureau, read their nomination and said, "Having seen the video, I can corroborate just how heroic this was. This guy had already killed one person, and he didn't sweat to kill anybody else, and you guys eliminated that threat, so my hat's off to both of you."

Col. Turner said, "Justin and Trey, I'm so proud of you guys. I see what you do every day, and you inspire me. You make me want to go out and work the road again. You inspire a whole agency to get out there and do what we all signed up for. I think about our core values, and it makes me want to create a couple more."

Troopers Gaedke and Hedrick each received a challenge coin from DPS and from Col. Turner, as well as certificates commemorating their service.

On February 3, 2025, Colonel Michael A. Turner was sworn in as the 25th superintendent of the Missouri State Highway Patrol.

The Honorable Kelly C. Broniec, Supreme Court of Missouri, administered the Oath of Office during a ceremony at the Missouri State Highway Patrol General Headquarters in Jefferson City, MO. Following Colonel Eric T. Olson's retirement announcement, Governor Mike Kehoe appointed Colonel Turner superintendent of the Patrol on December 26, 2024. Colonel Turner's appointment was confirmed on January 30 by the Missouri Senate.

"I am honored and humbled to take the Oath of Office as the 25th superintendent of the Missouri State Highway Patrol," said Colonel Turner. "It is especially meaningful to take the Oath surrounded by family and friends who have supported me since my law enforcement career began almost 30 years ago."

Turner was appointed to the Patrol on January 1, 1996, as a member of the 71st Recruit Class. Upon graduating, he was assigned to Troop F, Zone 5, Camden County. He was promoted to corporal and designated assistant supervisor of Zone 8, Callaway County, on April 1, 2001. He transferred to Zone 5, Camden/Miller counties on February 28, 2004. On April 29, 2007, he was promoted to sergeant and designated as supervisor of Zone 6, Moniteau/Morgan counties. Turner served as Troop F SWAT team leader from 2004 to 2011 and founded the Central Missouri Tactical Officers Association. He was promoted to lieutenant on November 1, 2011, and assigned to Troop F Headquarters. On March 1, 2015, Turner was promoted to captain and designated commanding officer of Troop F, Jefferson City. On April 1, 2019, Turner was promoted to major and named commander of the Support Services Bureau. On March 1, 2022, Turner was named commander of the Field Operations Bureau.

Colonel Turner was born in Texas and grew up in Kansas City, MO. He earned an Associate of Arts from Metropolitan Community College, a Bachelor of Arts in criminal justice from Columbia College, and a Master of Arts in sociology and criminal justice from Lincoln University. Texas advised that competitors would participate in physical fitness, firearms, driving, and an interview. Texas provided little other information about the competition and advised that competitors must be considered "road troopers" to be eligible to compete.

To determine the representatives of the Patrol, the Training Division hosted an in-house competition. Nine members chose to take the challenge.

After the completion of the physical fitness portion, the original idea was to provide competitors with the opportunity to practice at both the Emergency Vehicle Operations Course (EVOC) and the range, however, the Missouri weather had other ideas. Due to expected rain on March 4th, the EVOC portion was moved to the afternoon of March 3rd. Each competitor would participate in the "Green Course" which is the course every Patrol recruit must pass. It involves control of the patrol vehicle under heavy braking, sharp turns and changes in road surface. Each competitor was provided four laps of instruction to help prepare. Once the four laps were completed, each competitor executed three laps with their best lap being their official time.

On the early morning of March 4th, the competitors traveled to the outdoor range and were provided the opportunity to practice with their handgun, rifle and shotgun. After lunch, due to weather conditions, each member was provided one run through the course, which integrated all three platforms. The run was timed, which began with members carrying tires approximately 50-yards to elevate their heart rate prior to a 100-yard prone position shot. Competitors moved through the stages utilizing different shooting positions and weapons. Their overall time was combined with penalties for misses.

On the final day, March 5th, each competitor participated in an interview. The three-person panel asked questions related to general Patrol knowledge, including the Core Values, Mission and Vision, and the Law Enforcement Code of Ethics.

Sergeant Graydon Gaines and Trooper Olivia Imhoff were later announced as the two winners. Two alternates were also named in the event the winners were unable to attend. Trooper Hunter Hampton and Trooper Eleanore Ferrel were announced as the alternates. The winners or alternates will travel to Florence, TX to represent the Patrol.

A PATROL'S VEHICLE LEGACY: THE JOURNEY OF MSHP

On January 4, 2024, retired Missouri State Highway Patrol Sergeant Dan Crain's phone buzzed with a text message that unexpectedly transported him decades into the past. The sender was Matt Hallberg, a young man from North Aurora, IL, who had recently inherited a 1990 Chevrolet Caprice from his father, Doug Hallberg. But this wasn't just any old car. Matt believed it had once been a Missouri State Highway Patrol vehicle, more specifically, one assigned to Sgt. Crain himself.

At first, Sgt. Crain was skeptical. Over his 34-year career, he had been assigned countless patrol vehicles, swapping them out every 49,000 miles. How could this young man be so certain that this

particular vehicle was once his?

Then, Matt sent a photograph of a worn but legible document of the original Missouri State Highway Patrol SHP-375, Record of Service & Repair of Motor Equipment, found tucked away in the glove compartment. Sgt. Crain's doubts vanished the moment he saw it; the handwriting on the form was his own.

Unit #367 officially entered service on June 18, 1990. The records show that its last documented service with the Missouri State Highway Patrol was performed on June 15, 1992. After that, Matt learned Unit #367 was reassigned to another state agency, Child Services Division, likely in the summer of 1992.

The next chapter of the vehicle's life began a decade later. In 2002, a family friend of the Hallbergs purchased Unit #367 from a Kansas City eBay auction, paying either \$4,000 or \$7,500- Matt is not certain which. Six years later, Doug Hallberg bought the vehicle for just \$2,000, using it as a daily driver.

Then, in 2023, Matt officially became the third titled owner since the vehicle's retirement from state service. But to him, it's not just a car. It is a tangible piece of law enforcement history; one he is determined to restore.

Matt poured his time and effort into bringing Unit #367 back to its former glory. He carefully tracked down and installed period-correct law enforcement equipment, ensuring every detail was as close as possible to its original Missouri State Highway Patrol configuration. One of the awesome touches is a replica Missouri State Highway Patrol 367-HP license plate, honoring the vehicle's service and the trooper who once drove it.





As Matt continued to restore Unit #367, he reached out to Trooper Cole P. Justice, the current 367 in Troop H. Tpr. Justice and Matt have shared photographs and stories, developing a camaraderie over the vehicle's rich history. Tpr. Justice was fascinated by Matt's efforts and admired his dedication to preserving a part of MSHP history.

Meanwhile, Sgt. Crain reflected on his time with the car. Though the specifics of every vehicle he has driven over the years has faded, seeing the SHP-375 form and hearing Matt's story reignited a deep sense of connection. This is more than just an old patrol car, this is

a piece of his career, a part of Missouri State Highway Patrol history that survived long after its official retirement.

Today, Unit #367 is not just sitting in a garage. Matt takes it to car shows, proudly sharing its story with the public. What began as an inheritance has evolved into a rolling tribute to the men and women of the Missouri State Highway Patrol. Every patrol vehicle carries more than just miles; it carries memories. Thanks to Matt Hallberg, Unit #367's legacy lives on.



40 YEARS AGO

On March 2, 1985, 35-year-old Trooper James M. Froemdsdorf pulled over a driver for speeding on Interstate 55 near Brewer, MO. The driver, Jerome Mallett, fatally shot Trooper Froemdsdorf, inciting a massive manhunt by the Missouri State Highway Patrol and other law enforcement agencies. Jerome Mallett was executed by lethal injection on July 11, 2001.

30 YEARS AGO

In April 1995, Robbie the Robot retired to the Safety Education Center after years of dedicated service teaching safety information to kids and adults alike. Robbie the Robot first joined the Patrol in 1985.



20 YEARS AGO

On March 20, 2005, Sergeant Carl D. "Dewayne" Graham Jr. of Troop G was fatally shot in the line of duty outside his home near his patrol vehicle. Lance Shockley, the suspect in a fatal crash Sergeant Graham was investigating, was arrested and charged with Sergeant Graham's murder. He was convicted and sentenced to death, but, as of March 2025, he is attempting to appeal the decision in the Supreme Court.

10 YEARS AGO

In March 2015, members of Troop A participated in "Tip a Cop" at the Outback Steakhouse in Lee's Summit, raising nearly \$670 to support the Special Olympics.
