## Remembrance Run Touches The Heart

I've run a few marathons in my time, so I didn't think twice about signing up to take part in the first ever "5 Mile Run For Remembrance" last November. The plan is for this to become an annual event.

It all began when Ms. Beth Knight, a member of The MASTERS (Missouri Association of State Troopers Emergency Relief Society) decided to raise money to help provide aid to family members of fallen troopers across the state. (Beth has three brothers that are troopers with the Missouri State Highway Patrol.)

Local radio and television stations helped get the word out and on race day, hundreds of runners and walkers braved the cold and laced up their running shoes to do their part for the cause.

The event kicked off with a short prayer and the singing of the national anthem, which seemed to motivate every one of the 350 participants—young and old alike—into high gear. Then, we were off!

We seemed to be running straight into the chilly winds throughout most of the race, but no one seemed to mind. One of the reasons may have been the 30 signs placed along the five-mile course that displayed the

names of fellow troopers from across the state, all of whom have made the ultimate sacrifice in the line of duty. It was a fitting tribute to the sacrifice they made serving the citizens of the great state of Missouri.

I ran past quite a few names that brought back bittersweet memories: Sgt. Joseph G. "Joe" Schuengel, Trooper Ralph C. Tatoian, and Trooper Dennis E. Engelhard. I remembered talking to some of these guys, sharing jokes with them, working alongside them, respecting them for the officers they were. It was these kinds of sobering thoughts that made

me run just a little slower; breathe a little heavier.

But, then I started hearing the loud cheers from some of my co-workers, friends, and virtual strangers, who had gathered to watch, hand out water, or help keep the course safe for runners and walkers along the route. As I looked up, they smiled and waved, and encouraged me to continue on for the last couple of miles.

That brought it all home for me. The Patrol is like a big family, and that means sharing in each other's grief and sorrow, but also in their happiness and joy. More than anything else, as

# A Spotlight On ...

## Director Jerry Lee

*Department of Public Safety*



In October 2011, Mr. Jerry Lee became director of Missouri's Department of Public Safety. Governor Jay Nixon named the former St. Louis County police chief as the head of one of Missouri's largest state agencies. He comes to the department with 38 years of law enforcement experience, having retired as chief of the St. Louis County Police Department in 2009. After retiring, Director Lee served as a member of the St. Louis City Board of Police Commissioners. He has also served on various committees for the Missouri Police Chiefs Association and on several law enforcement advisory boards.

**Patrol News Editor Cheryl Cobb:**

Thank you so much for taking time to talk to our readers.

**DPS Director Jerry Lee:** Cheryl, thank you. I would like to compliment you and your staff for an outstanding publication. With employees across the state, I think it's very important to keep all of the employees of the Highway Patrol informed.

**Cheryl:** It's been at least six months since you stepped into the office of DPS director. In that time, what have you learned? Any surprises?

**Director Lee:** I've learned much about the size of DPS and its various functions, which affect all Missourians. DPS provides a tremendous amount of services to private citizens as well as law enforcement. The budget process at the state level is certainly a challenging and intricate process.

I feel very fortunate that each division has many outstanding leaders and employees who have prepared very detailed and thorough budgets. Having only been here six months, I began learning from the first day on the job and I continue to learn from the various divisions. While this was a terrible loss, I think the "Patrol family" did an outstanding job in supporting Teresa and Fred's family during these very difficult times. I know that the Patrol will always remember Tpr. Guthrie for making the ultimate sacrifice, and will honor his memory and never forget the sacrifice he made. That being said, I also know that the Patrol will always be there for the Guthrie family.

**Cheryl:** Please share with us what projects you feel need to be priori-

ties for Missouri's Department of Public Safety.

**Director Lee:** I think one of the ongoing and most important projects is interoperable communications. This has been a multi-year project and is nearing completion and implementation. Not only will this project benefit the Highway Patrol, but all of Public Safety. Another priority is our disaster response, as evidenced by the number of disasters that struck Missouri in 2011. Our disaster response during 2011 was outstanding by not only the Highway Patrol, but by other divisions within DPS. While these are important areas, our primary mission to protect and maintain the safety of Missourians remains the goal of DPS, as well as that of the Patrol. The Patrol has done an outstanding job in reducing fatalities on our highways through prevention, education, and enforcement.

**Cheryl:** What message do you wish to convey to the employees of the Missouri State Highway Patrol?

**Director Lee:** I would like to congratulate and commend you on being a member of one of the premier law enforcement agencies in the country. This can only be achieved with outstanding individuals such as our men and women of the Highway Patrol. You should be proud of yourselves and the Patrol.

# DPS Award Recognizes Rutledge, Hukill

After a concerned citizen contacted the Patrol with a report of suspicious behavior at a residence in Lockwood, MO, Troop D dispatched two troopers to investigate. On November 7, 2011, Trooper Kelsey J. Rutledge and Trooper Darwin R. Hukill followed up on the tip by initiating a “knock and talk”. At the Lockwood residence, they located two individuals. Upon running a computer check, it was discovered that both individuals had warrants issued for their arrest.

A check of the vehicle parked at the residence revealed it had been reported stolen in Pittsburg, KS. The troopers continued their investigation, which led to the execution of a search warrant at the residence. The search revealed numerous stolen items and a methamphetamine laboratory. A second residence was linked to the investigation, and additional stolen property was located there. The recovered property was from numerous residential and commercial thefts, and has an estimated value of \$100,000.

A follow-up investigation by Troopers Rutledge and Hukill, the Rural Crimes Investigative Unit, and area law enforcement agencies resulted in the clearing of over 20 theft cases in seven counties in Southwest Missouri and one county in Southeast Kansas.

To honor Troopers Rutledge and Hukill for their investigative abilities, keen sense of observation, and interviewing skills, DPS Director Jerry Lee presented them with the DPS Employee of the Month Award for March 2012. During a ceremony on March 26, 2012, at General Headquarters, Director Lee and Colonel Ron Replogle congratulated both troopers and expressed their appreciation for the work they do. Lt. Daniel S. Bracker, Troop D, spoke on behalf of Troop D.

“Kelsey’s and Darwin’s perseverance is a reflection of their character and indicative of being a member of the Patrol,” said Lt. Bracker. “They worked together to make this arrest

# Ceremony Marks End, Beginning

# DPS Honors Sgt. Trammell

**Polygraphist** (pə lig' rə-fist) — One who administers a polygraph. Sergeant Jason B. Trammell, Q/DDCC, (sär ' jənt jə' sün träm' əl) — An exceptional polygraphist.

Being a polygraphist is more than hooking up a few wires and understanding graphs. It's an art form. Understanding how stress affects people, sharp interviewing skills, patience, and keen observation can solve a case before the polygraph test even begins. This is precisely what Sgt. Trammell does.

On February 17, 2012, Lamar Police Department officers began investigating the death of a four-month-old baby. The child died while in the care of a 27-year-old babysitter. On February 20, Sgt. Trammell assisted the Lamar Police Department officers. As with every polygraph, Sgt. Trammell conducted a thorough pretest interview of the babysitter. During this pretest, the suspect confessed to shaking the baby and causing the injuries leading to his death. Thus, the actual polygraph and posttest (interpreting the graphs) was unnecessary.

On February 22, 2012, Webster County Sheriff's deputies were investigating the disappearance of a 28-year-old Springfield man. Sgt. Trammell assisted with the execution of a search warrant in Rogersville, MO. During the interview of an occupant at the residence, the man confessed to having a part in the murder of the missing man. The subject took officers to a location where they recovered the victim's body, and a second location where they recovered the murder weapon.

In both these cases, Sgt. Trammell secured a confession through skillful interviewing techniques. Because the evidence was circumstantial, the confessions were critical to resolving the case. To recognize Sgt. Trammell's interrogation ability, Department of Public Safety Director Jerry Lee presented him with the DPS Employee of the Month award for April 2012.

"I'm sure that to him, it's just another day at the office," said Major Luke Vislay, Q/CIB. "But, it's great that Jason's being recognized."

"Jason epitomizes the characteristics of our DDCC officers," said

Captain Kyle D. Marquart, Q/DDCC. "He does a great job every day. Congratulations, Jason, and thank you for the work you do."

Sgt. Trammell thanked those who attended the ceremony saying he was surprised and honored. "Any one of the guys I work with could be standing here," he said. He also thanked his wife, Aimee, and admitted, "Sometimes, the calls come in and it's not convenient."

# Looking Back ... in the Patrol News

### 40 years ago ...

*May 1972* — An elderly lady walked into the driver's examination station in Springfield with her operator's license in hand. She told the clerk she would like to take the test. The clerk, seeing the license, asked, "Are you expired?" The elderly lady replied, "No, I'm not, but my license is."

### 35 years ago ...

*June 1977* — Tpr. E.D. Springs, Troop C, initiated a traffic stop for excessive speed. The Arkansas license plate was "POLOCK". The driver said they were special issue plates. His name was Kleczkowski.

### 30 years ago ...

*May 1982* — The front cover showed members of the Patrol handling an anti-Ku-Klux-Klan demonstration in Hannibal. The demonstration took place during a Klan rally. There were no injuries incurred while order was being restored. The demonstration lasted approximately 15 minutes.

### 25 years ago ...

*June 1987* — On the back cover, a photo showed participants in that year's Law Enforcement Torch Run standing in front of the Hearnes Multipurpose Building in Columbia. ## Explore The World Of The Web LAR

The Patrol's Crime Laboratory has developed a way to make the task of evidence submission more streamlined: the ability for you to fill out Laboratory Analysis Requests (LAR) online before submitting the evidence to the lab. This Web-based evidence submission service (Web LAR) offers convenience, and will expedite the evidence submission process. This system allows submitting agencies the ability to enter the case information (at

any time of the day) into the Web LAR prior to arriving at the lab. The laboratory evidence technicians can then access your case information when you bring the evidence to the lab, resulting in significant savings of time for you at the lab evidence intake window.

Before using this new system, any law enforcement agency with Internet access must first register to submit evidence through the Web LAR. It is the submitting agency's prerogative

to decide who should have the access to enter cases into the system. To register, sign up through the Missouri State Highway Patrol's Web site ([www.mshp.dps.missouri.gov](http://www.mshp.dps.missouri.gov)). Click on the "Law Enforcement Portal" at the top of the screen. A small "Quick Links" box will appear on the top right portion of the screen. Select LAR, New User Registration, and complete the required information before selecting Register. You will need your agency's ORI number for this process.

Once your application is approved, you will receive a confirmation and password for the system. At that time, you can begin submitting evidence information electronically! For more information about the world of Web LAR, review **Under the Scope**, Volume 12, Issue 1.

## Summit Addresses Distracted Driving Dangers

The Missouri State Highway Patrol and the Missouri Department of Transportation hosted a Distracted Driving Summit on February 16-17, 2012, at the Capital Plaza Hotel, in Jefferson City. Eighty-one people attended. The summit highlighted issues related to distracted driving. As part of the summit, attendees divided into two groups (education and enforcement).

The education group developed a PowerPoint presentation about the effects of distracted driving. This presentation is being provided to all attendees. It is hoped the PowerPoint will aid them in educating Missouri citizens about distracted driving.

*The enforcement group attended training on the following:*

- Techniques for enforcing distracted driving laws;
- Developing local ordinances for distracted driving;
- New handheld cell phone ban law for commercial vehicles and buses;
- How to obtain Highway Safety grants for enforcement operations;
- How existing state laws apply to distracted driving; and
- The new Missouri crash report, including the proper recording of distracted/inattentive driving contributing circumstances.

# Survey Said ...

## Public Provides Feedback To MSHP

The results are in! The 2011 Missouri State Highway Patrol Public Opinion Survey gathered citizens' opinions about the agency and its employees, and their concerns about crime, being involved in traffic crashes, and public safety issues. A total of 481 individuals responded to the survey. A brief overview is below.

The majority of respondents (92 percent) indicated the Patrol was doing either an excellent or good job. Respondents said 94.9 percent felt the appearance, attitude, and demeanor of Patrol employees was excellent or good. In addition, respondents highly rated their competence.

Those answering the survey listed enforcing criminal laws (90.2 percent) as the most important Patrol duty. Detecting and deterring the flow of illegal drugs ranked second (81.1 percent), and traffic crash investigation came in third (77.4 percent). The survey asked respondents to rank a series of traffic laws aimed at reducing traffic crash deaths and injuries. Those who answered this question indicated enforcement of intoxicated driving laws was most important (90.1 percent). [The majority of respondents approved of law enforcement using sobriety checkpoints (90.2 percent).] This was followed by enforcing inattentive driving laws (85.0 percent) and enforcing aggressive driving laws (84.7 percent).

According to the survey, those areas needing improvement included enforcement of inattentive driving laws, hazardous driving violation laws, and aggressive driving laws. Respondents indicated not enough effort was given to these areas (51.7 percent, 32 percent, and 30.2 percent, respectively).

Respondents were slightly concerned about being victimized by crime while traveling on Missouri roadways (40.2 percent). Forty percent

were slightly concerned about crime in their residence or neighborhood. The greatest concern to respondents was related to being involved in a traffic crash (40.3 percent).

Respondents ranked 10 social issues facing America by their perceived order of importance. The survey indicated 57.1 percent perceived crime to be the most important issue facing the country. Problems relating to the economy were second with 41.5 percent. The third most important social issue was public education (34.1 percent).

When asked if they believed boating while intoxicated efforts deter alcohol-related boating accidents, 38.0 percent believed efforts to be effective. However, 46.9 percent of the re-

spondents did not feel knowledgeable enough to provide an opinion. When asked if they feel safe when engaged in activities on Missouri streams and rivers, 44.1 percent said they do. But, 49.5 percent said they do not engage in such activities.

Research and Development Division and the Information and Communications Technology Division personnel sent surveys to 3,000 Missourians age 18 and older. The survey respondents were individuals randomly selected from a database developed and maintained by USA Data. A total of 481 individuals responded to the 2011 Missouri State Highway Patrol Public Opinion Survey. For the complete report, visit the Patrol web site. The detachment honors team is certified through the National Guard. The funeral director calls when military honors are needed," said Jim. "The rule is the branch of service must provide two uniform people to fold and present the flag. The honors team provides the firing and "Taps". If, for some reason, the branch of service cannot send two people, then the honors team will conduct the service."

"I enjoy doing it, and the camaraderie." The group meets in The Barracks, a meeting place they painted to resemble dress blues. Jim says there are seven or eight detachments like theirs in Missouri.

Their detachment is named after a Marine killed in World War II: Cpl. Mason O. Yarborough Detachment 1081. The group heard about him when Yarborough's remains were repatriated from Makin Island in 1999. Yarborough was with Carson's Raiders. After he and 18 others were killed on Makin Island, the commander paid the island natives

to bury the men to keep the bodies from the Japanese. The remains of those men were located in 1999. Eighteen of them were taken to the

national cemetery in Arlington, VA. But the Yarborough family wanted Mason brought to Sikeston, MO.

"At that time, the reserve unit from St. Louis performed military honors for his burial," explained Jim. "After hearing the story, we asked his sisters and brother in Sikeston if they minded if we named our detachment after him."

Jim said the detachment also keeps busy with Toys For Tots every November and December. "There's no Marine Corps Reserves close enough, so our detachment does it. We're certified to be a local community organization. In 2011, we collected enough toys to give to 714 families (over 1,700 children)."

The group also works at a food stand at Bingo World two nights a week. When he's not busy with the honors team or working the food stand, Jim's in his woodworking shop. He's made bat racks for the little league field, and 12 cubicles for their batting helmets. He says it keeps things straightened up a bit, and they aren't stumbling over them.

## Howard John Lewis Hoffman



Howard John Lewis Hoffman, 83, of Columbia, formerly of Jefferson City, died on Easter Sunday, April 8, 2012, at The Neighborhoods by Tiger Place. Howard was born on July 29, 1928, in Wellington, MO, the son of Oscar and Edna Hoffman.

Howard married Elmira Kronshage on October 10, 1946. They lived on a farm in Bates City, MO, until moving to Columbia, when he began his career with the Missouri State Highway Patrol. Howard was appointed to the Missouri State Highway Patrol on September 18, 1955. He worked in Columbia, Jeffer-

Howard was preceded in death by his wife, Elmira, on October 19, 2011, after 65 years of marriage. Howard and

Elmira were blessed with and are survived by three children: Jim Hoffman (and his wife, Sharon), of Columbia, Janelle Patterson (and her husband, Lowell), of Columbia, and John Hoffman (and his wife, Christina), of Austin, Texas; and three beloved grandchildren, Sarah Hoffman, of Columbia, and Ellen Hoffman and Thomas Hoffman, of Austin, Texas. ## Student Safety: A Top Priority

Each year, the Missouri State Highway Patrol's Motor Vehicle Inspection Division inspects every school bus in the state. Between February 2 and April 30, 2012, a total of 11,934 school buses were inspected. Missouri's 2012 statewide approval rating was 88.3%, compared to 87.7% in 2011. A total of 256 Missouri school districts will be awarded the distinction of Total Fleet Excellence for approval ratings of 90% or higher with no buses placed out-of-service.

The 2012 statewide results are as follows:

- 10,538 buses received approval upon initial inspection. During the annual school bus program, buses found to be free of defective items are rated as "approved".
- 1,157 buses were deemed defective upon initial inspection. Buses with one or more minor defective items, yet deemed safe for the transport of students, are rated as "defective".
- 239 buses were placed out-of-

service upon initial inspection. Buses with one or more major defective items are deemed to be unsafe for the transport of students and are rated as "out-of-service" by inspection personnel.

The working relationship among the Motor Vehicle Inspection Division, Missouri's school districts, and contracting companies is key to the success of this program. The increase in this year's approval rating is a clear indicator that Missouri's pupil transportation professionals continue to strive to make student safety a top priority. The annual school bus inspection program ensures that Missouri's school buses are among the safest in the nation.

# Remembering Colonel Howard J.L. Hoffman

“When he visited the troops, he was the only colonel I remember who would walk around the office building and greet each employee at their work station. He was a good man and will be missed.” — *Retired Clerk IV Genie M. Allen.*

“On June 7, 1983, I was summoned to Colonel Hoffman’s office for a meeting. He asked if I wanted to transfer from Columbia to General Headquarters as the equal employment opportunity/affirmative action/recruiting officer. I promptly replied, ‘No.’ I liked working the road. His reply was, ‘Well, you are coming. It is up to you if you come kicking and screaming, or come peacefully, but you are coming.’

I will always be appreciative of him, because he saw ability in me that I had not recognized. I believe that the accomplishments of my career were due to this transfer. Over the years we laughed about that day many times. He was a gentle and quiet spoken man with a big heart for people and the Patrol. I will ever be grateful to him.” — *Retired DPS Director Charles R. Jackson*

“Colonel Hoffman stands out from all the others who made it to that position, as being a caring, understanding man, who stood for what was right. Even though he may have been limited as far as what he could do against wrong, I’ll be forever grateful to him for his stand for the right. There is no doubt in my mind that he was the best colonel I was ever privileged to serve under.” — *Retired Sergeant A.J. Stricker*

“I just want to say how much I respected the man ... and his family. When he was captain of Troop D,

Springfield, I was promoted to the rank of corporal. He, his wife, and his son, John, attended my graduation from Northwestern University’s Traffic Institute in June 1977, in Evanston, IL. Captain Hoffman was sent to represent Col. Al Lubker at the ceremony. The King Tut exhibit from Egypt was in Chicago at the time, and we all attended the exhibit. They were very friendly and personable folks.

Over the years during his career, I was fortunate to have interacted with him during different assignments. It always was a positive experience. He most definitely was an asset to our organization. We who knew him will most certainly miss him. Thank you, Colonel Hoffman, for your professional, unselfish, and friendly demeanor, and for leaving us with a legacy everyone should be proud of. You did make a difference, and we thank you, sir.” — *Retired Lieutenant Colonel James R. Brooks*

“When Colonel Hoffman was troop commander at Troop D, the following occurred: Then-Captain Hoffman called me into his office. He said, ‘Trooper Tandy, I appreciate you giving me, your fellow troopers, and the local news media the baseball scores and standings of the Saint Louis Cardinals and the Kansas City Royals every morning on your two-way radio. You probably did not ascertain that I come 10-41 very early and go 10-42 late. Do you think you could cease your giving all the sports scores on the Patrol radio? Also, I have heard you give everyone the weather forecast, too. Do I make myself clear?’ I politely replied, ‘Perfectly clear, captain.’” — *Retired Corporal W.R. Tandy*

“One day a few weeks after his retirement, I ran into Colonel Hoffman on the parking lot at GHQ. During the course of our conversation, he asked if I knew of any problems or concerns that may have come up since his departure. I made him aware of a couple of things that were causing a little grief in some quarters. He looked up thoughtfully and then said in his unique draw,

‘Well ... I just don’t think I’ll worry about it.’ Anyone who was around the colonel for any length of time will appreciate that response. He will be missed.” — *Retired Lt. Roy Herren*

“Howard Hoffman served *with me* and as my lieutenant when I was the troop commander at Troop F. He again served *with me* when we were both majors at General Headquarters. (I retired before he was appointed superintendent.) Howard was extremely capable in every position he ever held. “Howard was so loved at Capital Region Medical Center. He always was so kind and caring to our patients, families, staff, and to me. Howard would inspire others to keep on fighting. On the wall in our Rehabilitation Department, you will find a picture frame filled with wonderful pictures of Howard volunteering on the unit. We have a teen program during the summer. Howard also had a way with communicating to our teens. They would confide in him and they would listen to his advice.

It was a sad day for many of us when Howard and the love of his life, Elmira, moved to Columbia. We knew it was in their best interest, but selfishly, we wanted Howard here. # The Mourner's Bill Of Rights

Thought you should reach out to others as you do the work of mourner, you should not feel obligated to accept the unhelpful responses you may receive from some people. You are the one who is grieving, and as such, you have certain "rights" no one should try to take away from you. The following list is intended both to empower you to heal and to decide how others can and cannot help. This is not to discourage you from reaching out to others for help, but rather to assist you in distinguishing useful responses from hurtful ones.

**1. You have the right to experience your own unique grief.** No one else will grieve in exactly the same way you do. So, when you turn to others for help, don't allow

them to tell you what you should or should not be feeling.

**2. You have the right to talk about your grief.** Talking about your grief will help you heal. Seek out others who will allow you to talk as much as you want, as often as you want, about your grief. If at times you don't feel like talking, you also have the right to be silent.

**3. You have the right to feel a multitude of emotions.** Confusion, disorientation, fear, guilt, and relief are just a few of the emotions you might feel as part of your grief journey. Others may try to tell you that feeling angry, for example, is wrong. Don't take these judgmental responses to heart. Instead, find listeners who will accept your feelings without condition.

**4. You have the right to be tolerant of your physical and emotional limits.** Your feelings of loss and sadness will probably leave you feeling fatigued. Respect what your body and mind are telling you. Get daily rest. Eat balanced meals. Don't allow others to push you into doing things you don't feel ready to do.

**5. You have the right to experience "griefbursts".** Sometimes, out of nowhere, a powerful surge of grief may overcome you. This can be frightening, but is normal and natural. Find someone who understands and will let you talk it out.

**6. You have the right to make use of ritual.** The funeral ritual does more than acknowledge the death of someone loved. It helps provide you with the support of caring people. More importantly, the funeral

is a way for you to mourn. If others tell you the funeral or other healing rituals such as these are silly or unnecessary, don't listen.

7. **You have the right to embrace your spirituality.** If faith is a part of your life, express it in ways that seem appropriate to you. Allow yourself to be around people who understand and support your religious beliefs. If you feel angry at God, find someone to talk with who won't be critical of your feelings of hurt and abandonment.
8. **You have the right to search for meaning.** You may find yourself asking, "Why did he or she die? Why this way? Why now?" Some of your questions may have answers, but some may not. And, watch out for the clichéd responses some people may give you. Comments like, "It was God's will" or "Think of what you have to be thankful for" are not helpful and you do not have to accept them.
9. **You have the right to treasure your memories.** Memories are one of the best legacies that exist after the death of someone loved. You will always remember. Instead of ignoring your memories, find others with whom you can share them.
10. **You have the right to move toward your grief and heal.** Reconciling your grief will not happen quickly. Remember, grief is a process, not an event. Be patient and tolerant with yourself and avoid people who are impatient and intolerant with you. Neither you nor those around you must forget that the death of someone you loved changes your life forever.
